## TERMS AND CONDITIONS

### BOOKINGS

Bookings may only be held for 14 days from date of invoicing. A booking is considered confirmed once a 50% deposit is received by Adventure World. Payment of any deposit implies acceptance of these Terms of Agreement.

### BOOKING AND DEPOSIT POLICY

Full payment is required before 1st March 2012. Failure to make this payment on time may result in the release of your booking and the forfeit of your deposit. All payments are non-refundable.

### TICKETS

Tickets will only be issued upon full payment being received by Adventure World. Tickets can be collected from Adventure World Reception or we are able to send them to you by registered mail (standard fee applies).

**Competitor Tickets** – each team member will receive a Competitor Ticket that will allow them entry to Adventure World on the day of the Adventure Quest from 8am, registration commences at 8am.

**Spectator Tickets** – each team will receive a quantity of Spectator Tickets that will allow entry to Adventure World on the day of the Adventure Quest from 8am. Rides and attraction will be in operation from 10am. Additional Spectator Tickets may be pre-purchased from Adventure World at a cost of \$25.00 per ticket.

**Flexi Tickets** – are available with all packages. Flexi Tickets are valid for one general entry into Adventure World from 10.00am – 5.00pm during standard trading days, (excluding Good Friday), between the dates: 29th September 2011 – 29th April 2012. Additional Flexi Tickets may be pre-purchased from Adventure World at a cost of \$32.00 per ticket.

Tickets are non-transferable, non-refundable and cannot be updated or used for other special events. Spectators Tickets and Flexi Tickets may be on-sold, however please note Adventure World will not accept return of these tickets for refund or exchange.

### CANCELLATION POLICY

In the unfortunate event that a booking is cancelled, all payments will be forfeited. Notification of cancellation must be received in writing and signed by the authorised event organiser.

### FOOD AND BEVERAGE

Pre purchased catering packages are available. A range of Food and Beverages will also be available from Adventure World throughout the event. External catering or fast food will not be allowed into the park under any circumstances.

### ALCOHOL

Adventure World is a licensed venue and no alcoholic beverages may be brought into the park for consumption during the event. Spectators are welcome to take advantage of our licensed bar however competitors will not be allowed to compete if under the influence of alcohol.

### CLIENT RESPONSIBILITY

The welfare of competitors is of utmost importance. It is the responsibility of the client to ensure that all guests behave in an orderly manner during the event and that guests do not compromise the park's statutory licenses and insurance.

### INSURANCE

Adventure World cannot take responsibility for the damage or loss of items before, during or after Adventure Quest 2012 and recommends the appropriate insurance cover be arranged by the client if and as required. Participation is at the risk of the competitor. Lockers are available for hire throughout the day for a small fee.

### TEAM NUMBERS

Each Adventure Quest package includes 8 competitors which are split into two teams. Each team of 4 can consist of any combination of male and female competitors. The names of all team members are to be submitted to Adventure World prior to the commencement of the event with associated paperwork.

### BANNERS AND MASCOT

We are happy to have your banners, mascots or props displayed during the Adventure Quest event. Please ensure that you have them delivered to Adventure World no later than Friday 23rd March 2012.

### DAMAGE

The client is financially responsible for damage sustained to property or equipment owned by Adventure World, agents or contractors due to misconduct during Adventure Quest 2012.

### CONDUCT OF GUEST

The client acknowledges that Adventure World shall have the right to exclude or reject any guest/s who behaves in an objectionable or unreasonable manner, without any liability to the client or Adventure Quest 2012 guests whatsoever.

### INDEMNITY

The client shall indemnify Adventure World (their servants, agents and contractors) from and against any liability, damages and claims due to or incidental to the conduct and security of guests while within Adventure World and any property loss or damage of Adventure World and any guest. The client shall pay Adventure World (on demand) the amount of any such property loss or damage to Adventure World.

### MATTERS BEYOND ADVENTURE WORLD'S CONTROL

Where matters beyond the reasonable control of Adventure World impair or prevent Adventure World being able to perform its obligations under this agreement, to the extent that such matters affect Adventure World's ability to perform its obligations, the client releases Adventure World from any liability or loss incidental or consequential to such matters.

### WEATHER & RIDES

Adventure World is an outdoor venue. To ensure all guests are at all times in a fun and safe environment, in the event of inclement weather some rides may be restricted or unavailable.

Please be aware we do not offer ticket refunds or re-validation in the event of inclement weather. Adventure World reserves the right to reschedule the event.

Adventure World reserves the right to change special event games and activities, rides and/or attractions should circumstances arise.

### DEBT RECOVERY

In the event that legal action is required for Adventure World to recover any outstanding monies, the client will be responsible for all recovery costs.

### ADVERTISING

Adventure World must approve any promotion/marketing of your participation in Adventure Quest 2010 prior to release. This includes all advertising and promotional material including logos, pictures or images of Adventure World.

### COMPLIMENTARY TEAMS

Should a complimentary team win a place in the Adventure Quest, Adventure World will donate the proceeds from their winnings to the charity of their choice. They will be awarded the Adventure Quest Trophy.

### CONDITION

It is a condition of entry into Adventure World that any photograph, film, tape or other images taken of you whilst at the venue will be taken for the purpose of, and may be used, to help promote Adventure World. Unless you reach a prior agreement with Adventure World management to the contrary, your image may be published, broadcast, or otherwise distributed by Adventure World or any third party authorised by it in any media (with or without identification) and in publications within as well as outside Western Australia and you waive on an irrevocable, worldwide, perpetual basis all rights to object to such broadcast or distribution in any media.
