<b>PURPOSE OF EXCURSION</b>		
<p>Adventure World will assist the social interaction of your students and provide a safe environment that supports their physical fitness through energetic thrill rides, swimming and water play. Science teachers have also designed curriculum based programmes for student visits to Adventure World that demonstrate key learnings using Adventure World's unique rides and infrastructure.</p>		
<b>1.1 ENVIRONMENT</b>		
<p>Adventure World is Western Australia's premiere theme park set on 32 acres adjacent to Bibra Lake. It is 15 minutes drive from Fremantle and 20 minutes drive from Perth CBD. As a theme park environment, Adventure World is not just the most popular choice for school group excursions; it is also the cleanest, safest &amp; best supervised destination in Perth for a full day of fun. At Adventure World we have an ongoing commitment to consistently improving our operational service and safety standards.</p> <ul style="list-style-type: none"> <li>• Adventure World is suitable for all ages offering approximately 40% dry rides &amp; 60% wet rides. This includes an area dedicated to younger children called Dragon's Kingdom.</li> <li>• The maximum depth of any of the water attractions throughout the park is 1.6 metres.</li> <li>• Barriers are in place around the pool to deter guests from running and jumping into the water.</li> <li>• Adventure World staff are responsible for providing a safe and enjoyable environment for your students and therefore all rides, attractions and facilities are maintained and operated at a high level to ensure guest safety.</li> <li>• Schools may be assigned a "Group Area" as a meeting point for lunches, safety briefings and in case of emergencies. (Must be arranged prior to your arrival)</li> <li>• There are four toilet facilities located throughout the park with wheelchair access.</li> <li>• The entrance to Adventure World is 200 metres from the council car park or the overflow car park through the main admission gates</li> </ul>		
<b>1.2 TRANSPORT</b>		
<p>Transport to Adventure World should be arranged by each school attending. There are free of charge parking facilities on the corner of Progress &amp; Gwilliam Drives and an overflow car park off Progress Dve to the south of the park. Buses are welcome to park here for the duration of your visit if space permits. <b>1.3 STUDENTS</b>		
<p>Adventure World is suitable for all ages and welcomes students from all schools.</p> <p>Students can participate in any of the following:</p> <ul style="list-style-type: none"> <li>• Water rides, slides or thrill rides</li> <li>• Swimming in the Lagoon pool</li> <li>• Observing wildlife at the Aussie Wildlife Experience and Koi Pond</li> </ul> <p>Allergy Warning: At certain times throughout the year, the prevalence of bees increases due to the proximity of the surrounding nature reserve. Please be aware of this if any of your students have an allergy.</p> <p>Please note that there are physical requirements for some of our rides and these can be discussed in advance or</p>

#### **1.4 SUPERVISION**

Adventure World Team Members undergo a detailed training process within the Adventure World Learning & Development program. Team Members are located at each operating ride and at various locations throughout the park to assist Guests during their visit however, the teacher-in-charge and the school supervisory team are responsible for the supervision and any specific requirements of students at all times. A First Aid Room is centrally located and staffed with qualified First Aiders if required.

#### **1.5 EXTERNAL PROVIDER INFORMATION**

Each and every Adventure World Team member receives specialist training and holds the relevant industry formal qualification where one exists and/or is required.

All our Lifeguards, Pool Attendants and water-based Ride Operators are qualified with a Bronze Medallion emergency response qualification or higher.

Our already extensive safety procedures are constantly under review with high levels of training provided to all staff members throughout the season.

The Lagoon pool is constantly monitored by our qualified Lifeguard Team Members. The immaculately clean pool is equipped with a 5 metre observation tower giving Lifeguards an excellent position to view the activity within the entire pool area.

Our First Aid Team hold current Senior First Aid certificates.

Adventure World does not fall under the category requiring staff to hold Working With Children Police clearances.

Adventure World can provide your school group with an estimate of the number of visitors to the park on the day of you visit upon request. Please note that these numbers are an estimate only and cannot be guaranteed.

Adventure World has Public & Product Liability insurance totalling \$50,000,000. Certificates of Currency can be supplied upon request and are available to download at [www.adventureworld.net.au/group-functions/school-excursions](http://www.adventureworld.net.au/group-functions/school-excursions)

#### **2. SUPERVISION STRATEGIES**

Adventure World recommends the following supervision guidelines:

- All schools provide adequate adult supervisor to the student ratio of 1:10. As such, Adventure World will provide complimentary entry for 1 supervisor per 10 students.
- All schools provide an adult supervisor qualified with Bronze Medallion emergency response qualification or higher for the student ratio of 1:32 or part thereof.
- If a school is unable to meet the qualified supervisor with Bronze Medallion emergency response qualification or higher ratio, Adventure World, as an external provider, may provide the group with a Lifeguard for the day if available. Advanced notice is required and an hourly fee applies.
- By having your excursion co-ordinator and school supervisory staff participate in the day's activities with Adventure World staff, we can guarantee the highest level of effective supervision.
- As the park will be open to the general public at the same time as your visit, we ask that your supervisory team ensure that students are well supervised and their behaviour is appropriate to ensure an enjoyable day for all in the park.
- All standard Conditions of Entry apply. These are displayed at our front entrance and also available on our website. [www.adventureworld.net.au/group-functions/school-excursions](http://www.adventureworld.net.au/group-functions/school-excursions) Students may be approached by any member of the Adventure World team if they are perceived to be contravening the standard Conditions of Entry.

### **3. IDENTIFICATION OF EXCURSION PARTICIPANTS**

Schools are responsible for choosing a suitable method of identifying students to their supervisors. Please bear in mind that students are required to wear suitable swimming attire for water-based activities and thus standard school uniforms may not be suitable for identification purposes.

### **4. INFORMATION AND CONSENT**

Information and indemnity forms are the responsibility of the individual school. Further park details required by the school may be obtained from the website or from the Sales department.

### **5. COMMUNICATION STRATEGIES**

There is standard mobile phone reception at Adventure World.

We recommend that the school supervisory team have mobile phones for use during the excursion and that this number be given to the Sales Coordinator when booking the event so that Adventure World staff are able to get in contact with you should the need arise.

There is a public phone available for use at Guest Services.

Adventure World Team Members have access to a public address system should it be necessary.

### **6. EMERGENCY RESPONSE PLAN**

Adventure World has an evacuation procedure for the entire park. In the unlikely event that an evacuation is required, the Adventure World Operations Department (located in the Guest Services building) will direct all actions.

It is essential that school guests take direction from Adventure World Team Members at all times.

School groups should assemble at their group area in the event of an emergency and await further instructions from the Adventure World team.

Adventure World will not release details of the evacuation procedure to any school or group however we can brief your group upon arrival if requested.

Whistle blasts by any Lifeguard signifies that all students are to pay attention immediately to the nearest Lifeguard and then assemble at the designated group area if instructed to do so.

Teachers can increase safety by always ensuring they meet the recommended supervision requirements (outlined above) and by strongly encouraging students to adhere to the Adventure World Guidelines and Policies.

Adventure World also recommends that the teacher-in-charge has a list of all students and school staff attending the park in the event of a roll call being necessary.

All Adventure World Team Members are trained in evacuation procedures and our first priority is to ensure the safety of our guests.

### **7. BRIEFING STUDENTS AND SUPERVISORS**

To ensure a safe and enjoyable excursion to Adventure World, it is recommended that the teacher-in-charge communicate all relevant information to their students and supervisory team prior to your visit.

Upon request, students and supervisory staff will be briefed by an Adventure World Team member on the roles and responsibilities of the students, supervisory staff and Adventure World Team Members as well as safe practices on rides and attractions.

Students have the responsibility to follow all instructions of Lifeguards around water. Should any misconduct occur teachers will be notified and the student involved may be banned from aquatic areas.

Any students perceived to have been misbehaving in the park will be reported to the supervisory team and may be asked to leave the park.
